E. ACTIONS AND RESOLUTIONS:

- 1. Request by Attorney Anthony Gioffre with the firm of Cuddy & Feder, on behalf of their client WESTMED Medical Group for approval that the previously confirmed Special Exception Use approval be extended for a period of ninety days.
- 2. Request by Advisor to the Recreation Department on behalf of Manhattanville College for approval to use the Harrison Recreation's portable stage on Thursday, October 20, 2011. (Certificate of Insurance has been approved)
- 3. Request by Director of Community Services Nina Marraccini for authorization to accept the Adopt-a-Pantry Grant for the Harrison Food Pantry from Food Bank for Westchester in the amount of \$2,000 to be used as a line of credit for any food item on their inventory list.
- 4. Request by Commissioner of Public Works Anthony Robinson for authorization

to hire four (4) part time employees in the GTB/Parks division, effective Tuesday, October 11, 2011 at a rate of \$11 per hour. These employees are needed to supplement full time staff which is down four positions. **Further** funding is available in the GTB Operating Budget Account #001-1620-100-0102.

- 5. Request by Commissioner Robinson for authorization to hire up to fifteen (15) part time seasonal employees, effective Monday, October 24, 2011 at a rate of \$11 per hour. These seasonal employees will supplement full time staff during leaf season.

 Further, funding is available in the Highway Operating Budget Account #003-5142-100-0172.
- 6. Request by Attorney Frank McCullough, with the law firm of McCullough, Goldberger & Staudt, on behalf of their client Life Time Fitness, for approval to schedule a Public Hearing for a Special Exception Use Permit to demolish the soon-to-be vacant Gannett building at One Gannett Drive, and to construct a new, attractive facility of approximately 209,000 square feet on the approximately 22.4 acre property. Further requested is to reaffirm the Town's ownership of the sewer line located in Gannett Drive, which services all buildings located on Gannett Drives and dates back to the early 1970s as a Town line. (at the September 27th meeting, the Planning Board voted to grant Special Exception Use, Site Plan, Wetlands Permit and Slope Permit approval for the project.)
