My Dad, Vincent Montanti, had a very serious fall in our home and needed emergency assistance. If it wasn't for the quick response of the Police Officers and EMTs that day, my Dad might not have survived. It is a miracle he survived.

When I arrived at my home, I could hear Lt. Cindy Mercado saying my Dad was non-responsive and Police Officer Carmine Gentile calling him by name and telling my Dad to hang in there. As I approached the bathroom where my Dad fell, I found Officer Gentile holding my Dad's hand and talking with him, trying to keep him alert while Lt. Three other individuals helped out as well, Andy Mercado EMT, and another young man (I believe an EMT student) who was riding along with the EMTs that day (unfortunately I don't have his name), and Officer Barry Omeara. My Mom was in a panic and very worried and Officer Omeara showed her compassion by telling her he would pray for my Dad. Once my Dad was in the ambulance Officer Gentile came to my Mom to see if she was ok as well.

When we got to the emergency Lt. Cindy spoke to my Mom and me and tried to console us and offered us support and kept checking on my Mom's well being. Andy Mercado kept looking over to ensure my Mom was ok also.

That day was a trauma for my Dad, my Mom and I and we cannot thank those Officers and EMTs enough. I'm asking you to please extend our thanks to them and recognize them on our behalf. Their service and dedication are not taken for granted and are truly appreciated.

In addition, it is important to mention that due to my Dad's, health condition we had to use Harrison Emergency Services several times this year. Lt. Cindy was the EMT who responded and every single time her professional life saving skills, compassion, concern and interpersonal skills were demonstrated with excellence. Cindy is a Role Model for EMTs.

Our town is fortunate to have such great Officers and EMTs and I felt it was important to take the time out to write this letter to bring their excellence to your attention. Thank you and Happy Holidays to you and these individuals.

Naomi Oppman, resident, stated that she had concerns regarding employees retiring. An employee in the Court Clerk's office is retiring and the position is being replaced by a managerial position. But, in sanitation, people are retiring and there's no replacement for those people, but meanwhile they (sanitation) has lost 40% of their work force in the last three years.

Supervisor Walsh explained that the routes have been rearranged and there are some part time people on call, and when necessary they borrow from the Parks Department.

Ms. Oppman continued that three people in sanitation are retiring and what happens.

Councilman Cannella stated that their salaries are still in the budget.

Ms. Oppman asked if there was any discussion with the new administration regarding the budget.

Supervisor Walsh replied that every effort has been made to make the new administration fully aware.

Ms. Oppman: has there been any dialogue and communication asking if the new members are okay with this or do they have any issues.

Supervisor Walsh replied Yes.

Comptroller Maureen MacKenzie stated that in addition to the changes she read into the record, there have been additional changes to the assessment roll.

The Assessor had told the board that he was going to court for small claims, certiorari and that he would have to come back to us (the board) prior to the adoption of the budget with a number, which would be the final assessment roll number, which he has done. That number is \$136,437,851. The prior number that was in the preliminary budget was \$137,054,166. Due to the changes just from the Assessment Roll there is an increase of .471% total tax rate for the budget now, which is still preliminary, would be 4.713%, it was 4.201%. This does not affect the tax cap levy; it's the tax rate that has increased.

Supervisor Walsh thanked Assessor Mark Heinbockel for his hard work.

Assessor Mark Heinbockel stated that one of the reasons for the change in the budget is that the Ninth Judicial District Court has changed their protocol for small claims assessment review this year. They have accelerated the court timing by approximately four months. In past years we would start going to trial in January through June when we would establish a new assessment roll. This year the protocol changed and we were ordered to produce settlements for court experiences starting November 1st at a rate of thirty (30) decisions a week. It has accelerated our pace dramatically. We have approximately 385 small claims cases which is down from the prior year of 505. We are doing better than in the prior year in combating these issues but we have been forced to deal with these at an earlier pace which has affected the town's budget.

Lucille Held, resident said: You were asked a question, were you in on these changes. On the last changes that were just read.

Supervisor Walsh answered: No.

Mrs. Held addressed Comptroller Maureen MacKenzie: In the first expenditures, you had senior citizen meals, you added. In the revenue you have \$11,000. How does that work.

Comptroller Maureen MacKenzie answered: I increased both sides. I increased the revenue and the expenditures because the program has grown. So it's costing more to run the program but also the revenue is increasing, so I based it upon the revenue that we received so far this year and what we're expecting for next year and the same with the expenditures.

Mrs. Held: Why doesn't that balance out? If we get \$11,000 more why do we have to spend the 6,000 or what ever you did?

Ms. MacKenzie answered: Are you asking why the expenditures are more than the revenue? Because we subsidize the program for the seniors. They don't pay for the full lunch. That's the program that was started.

Supervisor Walsh responded: They don't pay the full cost. More seniors are joining the program. It's a good social occasion for them, they enjoy it thoroughly and each month more take part in it

Mrs. Held: If you spend more sounded off beat to her. If you're spending more and you're getting more you don't have to spend more, in her psychology. Mrs. Held continued does that mean that our taxes have gone up from the Preliminary Budget, from 4.2 to 4.5.

Ms. MacKenzie: 4.713.

Mrs. Held: so that's .5 points

Supervisor Walsh responded: Yes

Court Clerk Jackie Ricciardi addressed the Board: You read them, and she was trying to listen very quickly. She asked if she heard that the new Superintendent of Recreation is getting a raise.

Supervisor Walsh replied: Yes.

Ms. MacKenzie stated that she would like to be clear on that. What had happened was that when Mr. Salvo was given the promotion, it was brought to her attention that in the resolution it said that he (Mr. Salvo) would get 3% last year and another 3% the beginning of this year outside of any raises that were due to anybody else.

Personnel Manager Debra Scocchera stated that to being his salary up to par or even with the other positions ...

Supervisor Walsh: with all of the Department Heads.

Mrs. Scocchera replied: No, the Senior Rec people. He has to be above his She was asked to speak at the microphone.

She continued he, Mr. Salvo was told when he took the position in September that he would be given 3% and another 3% to bring him above his senior rec people. Unfortunately the resolution wasn't put together properly and that's why the correction was made.

Councilman Cannella stated in the absence of that he would actually be making less.

Ms. Ricciardi asked: So his salary was brought up to increase him so that as the head of the department he's making more than his people underneath him. And that's to go for all Department Heads?

Mrs. Walsh: That has not been addressed by the other members of the Board.

Someone in the audience asked a question to which Ms. Ricciardi replied that she's a Department Head and her staff made more than she did this year. She went on saying she wanted to make that clear. If that is happening for one Department Head she would appreciate it to happen for all Department Heads.

Mr. Cannella stated that as the year progresses, we not talking about big salaries, we're talking about the possibility that management does not get overtime and staff does, if it were to happen that because of the needs of the department we have people that are working behind manager, who end up making more than the manager obviously that the board would look at that and consider a way to rectify it by way of a stipend or otherwise. With any luck the overtime will be controlled and that won't happen.

Mrs. Walsh stated that it did happen this year.

Ms. Ricciardi stated: it did happen this year.

Mr. Cannella we understand that and we are aware of it and we looked at the numbers very hard. There are step changes in your department and we'll see how that goes. Certainly we agreed that since Management does not get overtime in certainly many peoples places, including yours and they work every bit and then some beyond the normal length. As you know we need to be very conservative and that's what we've done. We understand.

Mrs. Held: What you're really saying is that people that are in charge of the departments work overtime don't get paid overtime, only the employees below them?

Mr. Cannella answered: That is true in management in every business he's ever heard of. Management never gets overtime, staff people that get paid either hourly or by union contracts do.

2011 - - 452 - - c COMMENTS FOLLOWING THE ADOPTION OF THE 2012 FINAL BUDGET

Supervisor Walsh explained that she is voting no because the raises that she put into the Budget for people she felt deserved them and earned them were taken out and also because an additional policeman was added that had been discussed at great length at various meetings that was not approved at that time and now is there, and for those reasons and a few others that are in the changes that were made, she is voting no on the Budget.

Councilman Cannella stated that he would make the following comment, not in response because people have a right to vote positively or negatively as they see fit. On the question of management raises, which we addressed at the last meeting, we're not at a time where we think it's appropriate to do that. The consensus of the board was not to do that, and Joan made a comment at the last meeting that she didn't know we were pulling them down but we never knew that they were going in. That put us in a terrible position. Nobody likes to be the ogre that takes away increases that people come to expect because they're in the preliminary budget and they (the board) didn't appreciate being put into that position. But we were, and that's fine because it's the Mayor's budget. With respect to the second comment, an additional officer, it's a safety issue. We are mindful and have sat through hours and hours of police presentation which certainly we listened to. The Department has lost a great deal of manpower, safety comes first, in terms of the mindset of the majority of the board, we did what we could to be helpful, it's not big items; you take the difference between the mayor's budget and this, leaving aside some of these other items, if you ask me did you know about everyone of these prior to the preliminary budget, the answer is No. I knew about two or three of them, some of the other board members may have known more or less than he did, but that was basically it. You take the Mayor's Preliminary Budget and the Final Budget the differential is not significant. The goal is to stay below the cap, we did stay below the cap, it was not easy to do, it was the principle that guided this and that's the way we've dealt with it, you (supervisor walsh) is entitled to your vote, he believes that not voting for the budget was unfortunate.

Mrs. Walsh: No, she won't leave it at that. Like you said, it was my right, she worked very hard on that budget, it was, although you didn't know about the raises ahead of time, you certainly knew about them when you received the budget, which was considerably a time before the Hearings on it and she believes that her is as stands.

Councilwoman Amelio stated that what upset her the most, was that this was not a uniform raise, people were chosen and how can you give to some without giving to the others.

Supervisor Walsh stated: On performance.

Councilwoman Amelio: that's a very problematic issue for her.

Cannella Cannella stated that's not fair. It's not depending on performance. Every single person, every manager in the Town has worked far beyond than they were ever expected to do it before.

And if you said it was based on performance that some people did and some did not, that is an unfair statement and is inaccurate. They all deserve it.

Ms. Amelio said that if that was going to be the case we (the board) should have laid the ground work last year. You can't just indiscriminately choose who you're going to reward and who you're not going to reward. It's not fair. Ms. Amelio continued by apologizing to the Department Heads and Foremen's for not discussing the reductions in compensation proposed by the Mayor's Preliminary Budget prior to the last meeting. They certainly should have been told of our decision not to go ahead with it and again, it's not out of lack of our praise for their hard work; it's due to the economy and a tax cap that was very difficult for us (the board) to work with. We thank you for your dedication to the Town, these are different times, perhaps next year or the year after things will be different, but currently this is a difficult time.

Comptroller Maureen MacKenzie thanked her staff, Anna Maria Roberto, who's with Maureen day and night, Debra Scocchera and Debbie Leone, who she couldn't do without either. And Joan, to you and Bob (Paladino) for all your help and to the Board. You were all a great help to this. And all the employees and Department Heads of this Town who worked so hard to get us where we are.

John Katsogridakis stated that he was very confused between the argument that you have, Mrs. Mayor and the rest of the Board. I'm very confused. Why do you disagree with the board? We're talking about numbers.

Supervisor Walsh responded that she is entitled to her opinion and others are entitled to their opinion. She continued by saying that she disagreed about the new policeman, which was talked about that a number of times. So, I said no.

Chief of Police Anthony Marraccini thanked the board for listening and for extending his staff the courtesy at the last meeting when they put on the presentation. The Chief continued saying that he was here through a live teli-link and was in communication with his staff during the meeting. Unfortunately he was not able to be here in person but it was a difficult decision. He knows that he has made many hours of conversation, one new officer may not be a great number but at least it shows we're moving in the right direction. At the beginning of the meeting, the Supervisor read a letter regarding the EMS and if it weren't for the quick response of the EMT and the Police Officers her Dad might have died. Response times are critical. The letter also read how comforting the officers were, holding her fathers hand and comforting him.

Supervisor Walsh apologized to Officer Gentile for not mentioning his name.

Lucille Held stated she would like to get across to the Harrison taxpayers that when we give pay to a person we don't include all of the other things that go with it. When you give me the pay of a policeman or of anyone else, she would like to know in total what that addition is. Also, remember that everyone we hire, I'm not allowed to say it, but the Police Department, where a man can retire after twenty (20) years. Every person that we will hire from now on, and she hates to use the expression, will be a rope around our necks and at one time it will come when we have more retired people than those working for the Town of Harrison. We already have, possibly a three million odd dollar expenditure on retirees.

On behalf of the Association they wanted to thank Supervisor Walsh and Councilman Vetere for their many years of service to the town. Mostly people don't do it for the notoriety but because they believe they can make a difference. We thank you for doing that.

Also we wanted to let the Town Board and members of the Town to know that we have been working on a project for the last five (5) years, which is Heritage Trail Signs. The signs are 4' X 4' and are ready to go into the ground. We wanted to let you know that it will have a map that shows the Heritage Trail. Ms. Wilson showed pictures. Ron Belmont, Fred Sciliano, Steve Malfitano, and Joe Cannella were part of it. Hopefully in January 2012 we'll have an unveiling and all will be invited.

Supervisor Walsh asked is Ms. Wilson would explain to the residents where the trail is.

Councilman Sciliano stated that the best way to describe it is it goes from probably the new pool, heading northwest around the Lake, it basically encompasses the Lake.

Councilwoman Amelio asked if there was a historical significance to this trail.

Ms. Wilson answered: There is because it's part of the Revolutionary War, so it has a lot of historical significance. People take walks there. The markers will show where Passidomo Park is, which way to go to White Plains. There are trail markers on trees but now there will be actual signs.

Mrs. Walsh asked if the underground railroad site still visible.

Ms. Wilson wasn't sure.

Mr. Sciliano stated that over the years the Boy Scouts have tried to restore the trail.

REQUEST BY WEST HARRISON FIRE CHIEF STEVE MANCINI TO REPLACE A 2006 KME RESCUE/ENGINE THAT WAS DAMAGED BY FIRE AND DECLARED A TOTAL LOSS ON JULY 16, 2011.

Chief Mancini explained that July 2011 one of West Harrison Rescue Trucks suffered significant fire damage in Rockland County while it was being serviced by an authorized repair center. He continued saying that as the board knows he diligently attacked this issue with the service center and their representatives, Traveler's Insurance, he was able to negotiate a settlement of \$389,000 and change for their apparatus, there first offer was \$250,000. We purchased that apparatus approximately six years ago for \$460,000. In our current negotiations, Maureen just sent the Title to Travelers last week and we're still awaiting their settlement check. In an attempt to replace what we originally had would cost \$612,000. Mr. Mancini further stated that he's not attempting exactly what he had but hopes the replacement will be in the vicinity of \$550,000 to \$575,000 but he doesn't have design and specifications on it now. But, two issues he's fronted with right now is that the pricing he was issued was 2011 pricing. He was told by KME, the manufacturer of the apparatus that said pricing will go up 10 to 20% on parts on labor in 2012, which we then would be looking at a \$50 to \$60,000 increase for the manufacturer for the new apparatus. Also, he has about \$20,000 of equipment on various pallets in a factory in Pennsylvania, where KME is located, that is slated to go onto the replacement apparatus that we could use again. His proposal to the board, to secure the 2011 KME pricing saving us a tremendous amount of money.

Councilman Cannella stated that the nature of an emergency appropriation is because the equipment, the price factors, right; he would like to get into why the equipment is necessary and why it needs to be secured quickly.

Mr. Mancini stated that currently his department has three apparatus's, two are engines that carry water to fires, and one is a tower ladder. Those two engines that he has to rely on, one is 12 years old and is running everyday and the other one is 21 years old that he cannot rely on everyday for the residents of West Harrison and Purchase that his fire district covers. That apparatus was just at the repair facility this past week. Once again, he's limiting the actual number of calls that can go out on due to its age and reliability. Right now he can truly guarantee coverage with one engine.

Mr. Cannella: So what you're saying is that if we had a significant event, God forbid, given the apparatus you have now and without an immediate replacement of the lost piece of equipment, that, the health and safety of the town would be at risk.

Mr. Mancini: Absolutely. Unfortunately replacement, if you vote tonight and issue the resolution to him, he's still looking at 8 to 9 months for KME to manufacture new apparatus. If we go out to bid we're looking at maybe a year or so, because it's just going to prolong the replacement.

Town Attorney Frank Allegretti stated that we've looked into this issue and we've given the board our advice on this. They (the law department) did not take this lightly, they looked at the general municipal bidding requirements, the emergency exception that's contained in the cases, the comptroller opinions and we're unanimous advice is that it has to go out to bid. This is not the type of emergency situation envisioned, it's not like a boiler that goes out in the middle of the winter, during heating season, where you can't wait for the bidding process to evolve and a bidder to emerge.....

Councilman Cannella: So this is much more sensitive.

Mr. Allegretti: I understand that but the board asked for our advice, three lawyers looked into it and our advice is to go out to bid.

Councilman Cannella asked that the matter be taken into executive session.
