

Mark Weingarten Partner in the law firm of DelBello, Donnellan, Weingarten, Wise & Weiderkehr representing Avalon Bay Communities Inc. addressed the Board in connection with a request to amend the Town's zoning ordinance and zoning map. The request would establish a new Transit Oriented Development (TOD) district and to rezone the current Professional Business District to the new TOD zone. The development site fronts on Halstead Avenue and consists on what is known as the East Parcel, the West Parcel and the Road Way Parcel. The ultimate goal is to build a mixed use community consisting of three buildings. The buildings will contain 136 luxury market rate apartment homes, seven workforce housing apartment homes. In addition to the apartment homes there will be approximately 27,000 square feet of neighborhood retail, restaurant and other commercial uses. The project will also include a total of 769 parking spaces of which 475 will be commuter spaces owned by the MTA, 108 spaces for the commercial tenants and 186 spaces to service the residential tenants of the community. Also included will be public open space plazas and direct pedestrian access will be created to the train from the site.

Mr. Weingaraten made a presentation to the Board on the Harrison Transit Oriented Development Project.




Site Plan - Ground Level






Site Plan - Typical Level








PUBLIC HEARING RE: SPECIAL EXCEPTION USE PERMIT FOR WESTCHESTER JOINT WATER WORKS AND THE UPGRADE OF THEIR KENILWORTH BOOSTER WATER PUMP STATION

On motion of Councilman Cannella, seconded by Councilwoman Amelio, the hearing was opened.

Supervisor Belmont announced that this was a public hearing for a Special Exception Use Permit for Westchester Joint Water Works to upgrade their Kenilworth Booster Water Pump Station.

Mr. Tony Cannetta, Manager of the Westchester Joint Water Works (WJWW) addressed the Board. Mr. Cannetta recapped the requirements for new a pump house. The WJWW system is approximately 27 square miles in area. Water comes into the WJWW system from two sources; the southern part of the area comes from Shaft 22 by gravity into the system and the other half of the water comes from Rye Lake. The two waters meet approximately in the middle, generally around I-287 geographically. Many years ago WJWW was ordered to replace the Rye Lake source with a filter plant. WJWW asked for additional time to evaluate other alternatives. The alternative that has been sort of agreed to with the State and other agencies is to replace the Rye Lake source with a connection to Shaft 20 of the Delaware aqueduct. That will take seven or eight years, possibly longer depending on approvals. In the meantime we have an interim plan to maximize the use of UV treated water, which is available from Shaft 22. Water from Shaft 22 comes to us by gravity and can only get by gravity up to about I-287 (North Street). We would need to pump it north of I-287 and the location of the pumping would be at an existing pumping station on the Kenilworth site. The pump station that is there now is very small and hasn't been used in many years. We are proposing a pre-fab station. It would be constructed off site and delivered.
