## V - - 2013 - - 087 <u>UPDATES BY MAYOR RON BELMONT</u> <u>RE: COMMUTER PARKING LOT AND THE STAR EXEMPTION</u> <u>AND UPDATES BY ANTHONY ROBINSON, COMMISSIONER OF PUBLIC WORKS</u>

Mayor Belmont said he wanted to explain the situation in our commuter parking lot. As you all know Metro North has suffered a power outage due to mishap at the Mt. Vernon Station. At first I was asked to give up 10 to 12 parking spaces and work began last week and grew to over 50 spaces. I have been monitoring the parking situation daily. The Town has made the decision to allow commuters to park on residential streets but will still have to abide by all the rules and regulations. The only thing that has been relaxed is the time limits, whereas the two and four hour limits have been waived. You cannot park on Halstead or Harrison Avenue or in the business district just in some neighborhoods that are in walking proximity to the station. Also the Park Avenue/Purdy Street lot is available for commuter parking. You do have to have a valid Town of Harrison Commuter Parking Permit to park on the residential streets and of course to park in our commuter lots. Unfortunately the 50 or 60 spots that Con Edison has taken may not be available to us for a few weeks. Throughout this entire week my main concern was the welfare and safety of our residents. On Saturday afternoon they started to put the power on. It was successful; the power went up slowly and they were able to get the voltage that they needed to power some of the trains. We had many emergency response vehicles on hand Saturday afternoon and evening as they powered up in case a situation occurred that was not expected. My office is available if you have any questions.

Mayor Belmont informed residents that they should be receiving their STAR Application by October 10, 2013 and if you do not receive the STAR Application call our Assessor's office for the State Taxation Department phone number. This is for Basic STAR not the Enhanced STAR.

Anthony Robinson, Commissioner of Public Works said as a point of information, we started some prep work for the resurfacing project, our cape seal work. Residents can find information on our website about this and our cable channel. In addition to that, the streets that are going to be affected will be posted by the contractor at least 24 hours in advance and they will also hand out informational flyers on the process, traffic, what to expect and road restrictions.
