AUTHORIZATION TO ENTER INTO A PROFESSIONAL SERVICES CONTRACT WITH DOLPH ROTFELD ENGINEERING FOR WORK RELATED TO THE DESIGN OF STORMWATER IMPROVEMENTS AT THE ORGANIC YARD WASTE TRANSFER STATION

Village Engineer Mike Amodeo said this is in relation to our Department of Public Works (DPW) site near the airport. We are required to perform some upgrades and some storm water improvements due to the proximity of the garage to the reservoir. This is the design work to perform those upgrades.

Commissioner of Public Works Anthony Robinson said the Town operates an organic yard waste transfer facility on Route 120 near Westchester County Airport. Town DPW employees transport leaves, brush and grass collected from Town and residential properties and deposit them at the site to await transfer. Permit holding landscapers transport organic materials there as well. These are then loaded onto trucks for disposal/recycling per IMA with Westchester County. We pay a reduced, subsidized rate for disposal by taking advantage of economies of scale resultant from the participation in this program by other County communities. On October 15 2013, New York City Department of Environmental Protection (NYCDEP) issued a Notice of Violation for the operation of a solid waste management facility within 1,000 feet of the Kensico Reservoir and Reservoir Stem. They directed that we were to immediately cease all transportation, importation, storage and transfer of all organic materials to the site, including leaves, brush and grass. Their contention was that runoff from these materials may have a deleterious effect on the drinking water supply. After consultation with our legal team it was decided that the best course of action was to apply for a variance from the watershed regulations that would allow us to continue to operate. On January 5, 2015 the NYCDEP conditionally granted that variance. One condition is that we must make several storm water management improvements to the site to reduce/eliminate the potential for pollutants to enter the reservoir system. These include re-grading, paving, drainage improvements and special contaminant filter installation. The second condition is that we may no longer process grass clippings from any source at the site. We are therefore notifying residents and landscapers that we will no longer be accepting grass clippings. We will continue to collect bagged leaves, brush and bulk leaves (in season). Town forces will no longer perform curbside collection of brown bags which contain grass clippings. Town forces will begin mulching all grass and leaves on Town properties and will not collect and transport these materials to the site. We are suggesting that residents and landscapers do the same. In addition to the suggested mulch mowing, there may be private, fee based disposal options available such as automated collection and resident/landscaper transport of materials to vendor owned processing sites. The benefits of mulch mowing are: Helps reduce the total volume of organic material from being process through the County organic waste stream. Helps create healthier soils in turf areas and provides a source of free mulch for landscape beds. Helps keep organic material out of the stormwater system and reduces organic pollutants flowing into

reservoirs, streams and the Long Island Sound and reallocates DPW crews to other important business. Due to the ruling by the NYCDEP, this policy will be effective immediately. In the weeks to come the Town will further communicate this new policy to residents and landscapers through: mailings, web site postings, government access cable station, flyers and signs and the Mayor's column and possibly robo-calls. We will be contacting the Greenburgh Nature Center, who in cooperation with Westchester County, supports LELE Program – Love 'Em and Leave 'Em, which promotes mulch mowing. They will provide mulch mowing demonstrations at dates to be announced.
