Town Code - Fire Prevention Chapter 143

Section 143-11. Fees.

Installation of Sprinkler System Fees:

Installation/Alteration of a Commercial System:

The fee for the **installation** of a commercial or industrial fire sprinkler systems shall be base upon the following schedule:

| System Size: | <u>Small</u> (1-25 heads) | <u>Intermediate</u> (26-100 heads) | <u>Large</u> (Over 100 heads) |
|--------------|------------------------------|---------------------------------------|----------------------------------|
| | \$300.00 | \$400.00 | \$600.00 |

The fee for the **alteration** of an existing commercial fire sprinkler or fire standpipe system is based upon the following schedule:

| System Size: | <u>Small</u> (1-25 heads) | <u>Intermediate</u> (26-100 heads) | <u>Large</u> (Over 100 heads) |
|--------------|------------------------------|---------------------------------------|----------------------------------|
| | \$250.00 | \$300.00 | \$400.00 |

Fire Standpipe Alterations: \$200.00

If the sprinkler system should fail the inspection and/or acceptance test, a new inspection and/or acceptance test must be preformed and the fee of \$100 must be paid prior to the next inspection or test.

Residential Sprinkler System:

The fee for the installation of a residential fire sprinkler system shall be as follows:

Alteration or addition to a residential fire sprinkler system: \$150.00

Town Code - Fire Prevention Chapter 143
Section 143-1 1, Fees.

The following fees shall be established for permits, licenses, approvals, certificates, and other functions performed under this Fire Code and shall be payable to the Town of Harrison. Such fees shall accompany each application for a permit, license, approval, certificate, or other fee-related Fire Code provisions:

Permit fees shall be as follows:

| Temporary permit for installation or removal of a tank for storage of flammable liquids and combustible liquids: | \$125.00 per permit |
| Temporary permit to install gases other than those used in Welding: | \$125.00 per permit |
| Temporary permit for each tent or portable structure: | \$125.00 per permit |
| Permit for temporary use of pyrotechnics: | \$150.00 per day |
| Permit for temporary storage in a fire zone: | \$100.00 per permit |
| Annual permit for storage of flammable liquid (commercial only): | \$200.00 per permit |
| Annual permit for day nursery, convalescent home and home for the aged: | \$200.00 per permit |
| Annual permit for use of acetylene or other gases used in connection with welding: | \$150.00 per permit |
| Annual license to install suppression systems: | \$150.00 yearly |
| Annual permit for commercial suppression systems, including but not limited to sprinklers, standpipes, chemical and over-cooking equipment: | |

| 1) For buildings or structures 5,000 square feet and under: | \$200.00 |
| 2) For buildings or structures over 5,000 square feet: | \$500.00 |

Annual Permit for Smoke & Heat Detection Fire Alarm System:

MULTIPLE DWELLING BUILDINGS:

Small residential smoke and heat detection

System: 3-5 smoke/heat detectors

Annual Fire Safety Inspection

\$60.00 yearly

Medium residential smoke and heat detection

System: 6-10 smoke/heat detectors

Annual Fire Safety Inspection

\$100.00 yearly

Large residential smoke and heat detection

System: 11 or more smoke/heat detectors

Annual Fire and Safety Inspection

\$300.00 yearly

MIXED USE COMMERCIAL/RESIDENTIAL BUILDINGS:

Small smoke and heat detection system:

3-5 smoke/heat detectors

Annual Fire Safety Inspection

\$100.00 yearly

Medium smoke and heat detection system:

5-10 smoke/heat detectors

Annual Fire Safety Inspection

\$200.00 yearly

Large smoke and heat detection system:

11 or more smoke/heat detectors

Annual Fire Safety Inspection

\$400.00 yearly

COMMERCIAL USE BUILDINGS:

Less than 10,000 square feet

\$100.00 yearly

10,000 square feet to 50,000 square feet

\$300.00 yearly

50,001 square feet to 100,000 square feet

\$600.00 yearly

100,001 square feet and over

\$1,000.00 yr.

All annual permits shall expire on December 31 of the year of issuance.
