Kellard Sessions Consulting is pleased to provide this proposal for civil engineering services required for the preparation of a Preliminary Site Plan for the expansion of the existing municipal parking lot on Fremont Street located in the Town/Village of Harrison. It is our understanding that the Town is considering combining and improving the existing parking lot located on Fremont Street with the Town owned lands on Halstead Avenue. An intermediate, privately owned parcel is being considered for purchase by the Town to facilitate the expansion. Kellard Sessions Consulting shall prepare Preliminary Site Plan and Grading Plan for review and consideration by the Town to assess the feasibility and overall benefit of the expanded parking. Upon approval and authorization from the Town, Kellard Sessions Consulting shall provide a subsequent proposal for the scope of services required for the preparation of final design drawings and design of associated improvements, as required, to develop construction documents for bidding purposes.

Kellard Sessions Consulting shall provide the following services:

I. BASE MAPPING

Kellard Sessions Consulting shall prepare a CADD base file of the project site. The base file shall be prepared from a digital boundary and topographic survey to be provided by the owner's surveyor.

II. SITE PLAN PHASE

A. Site Plans

Kellard Sessions Consulting shall design and prepare a Site Plan package to the Town/Village of Harrison for review by Town Staff and the Town Board. The plan package will include the proposed parking lot layout, plus one (1) additional alternative in the event the Town were to acquire an adjacent fourth parcel. The plan package shall consist of the following for both alternatives:

- 1) <u>Existing Conditions Plan</u> existing conditions and existing improvements to be demolished/removed.
- 2) <u>Layout Plan</u> shown with dimensioning for access drives, parking spaces, sidewalks, curbing, retaining walls, directional signage, site lighting, drainage improvements and landscaping.
- 3) <u>Grading Plan</u> potential areas for stormwater management and mitigation facilities will be illustrated. Proposed two (2) foot contour intervals, including spot grade elevations, top and bottom wall elevations and driveway profiles.

B. <u>Site Plan Revisions</u>

Kellard Sessions Consulting shall revise the site plans, as required, to address the comments of the Town of Harrison.



III. MEETINGS PHASE

Kellard Sessions Consulting shall prepare for and attend meetings, as requested, before the Town of Harrison Town Board, Planning Board and with the Town Engineer, as requested. For the purpose of this proposal, it is assumed that a total of four (4) meetings will be required.

Additional services shall include all services not specifically defined within Scope of Services above. If required, additional services shall be billed in accordance with the hourly rate schedule for the year services are performed or under separate contract.
