Mr. Germani:

Please allow this letter to serve as a plan review fee proposal on the Harrison Recreation & Community Center project located at 270 Harrison Avenue in Harrison, NY. Our plan review fee proposal is based on the KG+D Architects drawing <u>CC-1</u> dated June 1, 2020, and marked "Design Development". Our plan review fees are based on the estimated cost of construction in accordance with the International Code Council Building Valuation Data (BVD) table.

As indicated in the above referenced documents, this new construction project consists of a 54,430 nominal SF 3-story building, including one level of parking all of Type IIB Construction and Occupancy Classifications A-3, S-2.

As such, the Building Review fee is \$5,580. All other requested code disciplines would each be \$1,395. This proposal reflects discounting for simplicity of floor plan. Assuming all code discipline reviews requested are performed, the total fee would be as follows:
