



Such recommendation must be confirmed by a resolution of the Town Board prior to the issuance of a building permit conforming to the recommendations".

Pursuant to Town Code, our remarks and recommendations for the development of this property are as follows:

The existing FEMA Flood Plain Elevation at this property is 64.0 feet (NGVD 1988), as shown on the FEMA Flood Insurance Study dated September 28, 2007

The proposed First Floor Elevation shall be 74.00 feet as shown on site plans dated May 17, 2022, prepared SMM Architect PLLC.

The proposed Garage Floor Elevation shall be 64.60 feet as shown on site plans dated May 17, 2022, prepared SMM Architect PLLC.

As reflected in the above mentioned plan, there shall be no substantial grade change permitted on this property.

An as-built survey from a New York State Licensed Surveyor will be required. The as-built shall include the flood plain elevation, and all floor elevations. As-built must also show compliance with Town building height regulations, as well as surface information verifying no grade change. This survey must be submitted to and approved by this department prior to issuance of a Certificate of Occupancy.

In order to verify the structure and all utilities have been built safely above the Base Flood Elevation, an Elevation Certificate must be submitted and approved by the Engineering Department prior to issuance of a Certificate of Occupancy.

Flood resistant materials must be used within all areas permitted below the Base Flood Elevation. All building materials below this level must be certified by the design professional upon completion of construction.

All building utilities (electrical, mechanical, sewer vents, etc.) must be at least 2 feet above the Base Flood Elevation and must be certified by the design professional upon completion of construction.

The design professional shall submit written certification to the Engineering Department of the installation of the flood vents as well as the flood vent certificates prior to the issuance of a Certificate of Occupancy.

Enclosed areas within a Floodplain are designed to be flooded, and can be used only for parking vehicles, storage, or access to the elevated living area. A Non Conversion agreement must be submitted and signed by the property owner prior to issuance of a Certificate of Occupancy.

No items shall be placed in the floodway limits without the approval from the Engineering Department.





2022 - - 345 OLD BUSINESS/PUBLIC COMMENTS

Town Attorney, Frank Allegretti, addressed the Board with the following statement:

I want to take this opportunity to respond to the unwarranted, unprovoked and baseless attacks that were made against me and my colleague Jonathan Kraut at the last Town Board meeting by Councilwoman Leader in connection with her statements made regarding the new litigation filed on behalf of Angela Bommarito.

To begin with, I have never in my 20+ years as Town Attorney have seen a Town Board member champion the cause of a private litigant whose interests are adverse to the interests of the Town of Harrison. Mr. Kraut and I were accused by Ms. Leader of "gross negligence" in the handling of this matter – and demanded our resignations. Nothing can be further from the truth. Ms. Leader's egregious breach of her fiduciary duty as a Town Board member should require at a minimum her recusal for any future deliberations on this matter and perhaps her resignation from the Board.

The truth is, Ms. Bommarito was a volunteer firefighter back in 2016 who reported an issue to our personnel manager. I was asked to attend a meeting with Ms. B and the personnel manager. I knew nothing about the issue beforehand. During our meeting she made allegations of harassment, stalking, etc. against someone she admitted having had a consensual relationship with and who happened to be a DPW worker with the Town of Harrison. That person was Henry Mohr. At that time, I advised Ms. B to go to the police station, file a report of what was happening to her and to seek an order of protection. Ms. B went to our PD either that day or the next day as per my advice and she filed such a report. As a result of that report, the person was charged with a crime, and Ms. B received a temporary order of protection and then a permanent order of protection when his criminal case was concluded. Subsequently, when at the next annual election of the FD after the resolution of the criminal case, the TB refused to accept the slate of FD officers that included Mr. Mohr as one of the elected chiefs by members of the FD.

I had nothing to do with her resignation from the volunteer fire dept and I had no further interactions with Ms. B....nor did Mr. Kraut. Ms. B hired a lawyer approximately 6 months later who then sought a large monetary settlement from the Town under the threat of going to the press with her allegations of employment discrimination and harassment...which was tantamount to extortion. This demand for a monetary settlement was reported to the Town Board and based upon the facts, there was no interest from that Board in such a settlement. Neither Mr. Kraut or I as municipal counsel have any authority to settle any matter... as that is the sole purview of the majority of the 5 member Town Board---and Ms. Leader knows this---or she should know this.

That attorney then filed a claim with the EEOC in May of 2017. The Town retained outside counsel to represent the Town at that time who submitted a comprehensive response to

the EEOC Charge of Discrimination. The EEOC investigation referenced by Ms. Leader conducted by 1 investigator and the ensuing report was deeply flawed and was filled with misstatements of fact, law and our level of cooperation. For example, the report said the Town did not provide any documents that was requested by EEOC which was completely untrue. Our outside counsel had filed a written response to the EEOC charge, fully cooperated with them and provided all requested docs. There were and still are significant issues as to whether a volunteer firefighter is covered under federal employment laws and whether the town is civilly responsible for the off-duty conduct of an employee in connection with issues that arose from a consensual relationship by 2 consenting adults.

This matter was never advanced by Ms. B or the EEOC as no lawsuit was filed until June of 2022, more than 6 years after the occurrence. My office actually closed the file was it was dormant for so long.

The fact of the matter was that the TB could have decided to settle this matter on any basis over the last 6 years had they wanted to. I do not recall you making any motion to resolve the matter since you have been on the Board...and based on your inherent conflict of interest you could not do so at this time. There are a few questions that you need to answer councilwoman Leader – did you or anyone on your behalf reach out to the EEOC or the DOJ in an effort to influence or move the case along? Another question – did you or anyone on your behalf reach out to Ms. B, her lawyer or family members to discuss this matter and perhaps to give them updates that you received in our private and confidential executive sessions?

This file was not mishandled – your attacks on prior town board members, Jonathan and me were outrageous, deeply disturbing and a clear breach of your ethical and fiduciary obligations to the Town in order to serve your own political interests. The fact that you now claim you ran for office to champion the cause of this claimant coupled with your actions and statements made last meeting and to the press mandates that at the very least you must recuse yourself from any discussion or consideration of this matter as you have violated every ethical responsibility and fiduciary obligation that you have to the Town and to each and every resident – and perhaps Councilwoman Leader it is you that should resign from the Board.
