2016 - - 448 OLD BUSINESS

Harrison resident Roy Aletti addressed the Board. He thanked the Town Board and the Mayor for expediting the delivery and set-up of the Doughboy statue and explained that he was proud to live in a town that recognizes Veteran's from all eras.

Supervisor Belmont thanked Mr. Aletti for his involvement in the process.

Harrison resident Rena Hecht addressed the Board with her concerns about the quality of life in our town. She explained that surrounding towns have passed ordinances to protect the quality of life in their towns.

Councilwoman Amelio explained that somehow she was getting the impression that some of the people are thinking the Board is not trying to do anything about the gun store and that was disturbing to her. We have two residents that are working with our Attorneys and I want you to understand that we are working on things. There is a momentum that exists. We understand your concerns.

Harrison resident Matt Benson addressed the Board. He said the residents are your partners; this is how a democratic government works. The people who are concerned about issues actually get involved and work side by side with their elected officials to insure that they are heard. We are looking for a location based ordinance, not ban guns, not disallow the ability to sell guns and not violate second amendment rights but for the town to carefully address and create a location based ordinance.

Councilman Malfitano replied that if it were that simple or easy it would be done. If we can find something we will act on it. The last thing we are going to do is put the Town/Village of Harrison in a position with legal action.

Councilwoman Amelio said one of the things we are working on is a location chart. We are actively looking and investigating everything we can.

Harrison resident Linda Spero asked the Board why wasn't any of this addressed before leases were signed and permits issued. She believes that things were missed somewhere.

Harrison resident Watson Baker said he understands that people are concerned about their children and guns near schools but said a gun is a tool and nothing more. It has always been a tool; in the wrong hands it can be a terrible weapon but it is still regardless a tool.

If you are really concerned and really want your kids safe I suggest you put off duty officers in the school.

Harrison resident Jill Valenti said why during the permitting process nothing was done?

Village Attorney Kraut replied that whether we are reviewing the internal process or not and what that review may determine and what information we may share with the Board is not necessarily something we carry out at a public meeting. Mr. Kraut understood the topic is one for differences of opinion and also for very passionate views. I can tell you that an exhaustive amount of time has been spent, by the law department, looking at various legal issues and what options exist. The Building Inspector cannot change the process because they feel a store is a good or bad use; there has to be some level of understanding when someone applies for a permit that the laws of the town are what need to be followed. The law department remains completely open minded for people coming forward with actual cases that are supported by law. We are tending to see, repetitively, is just the opposite. We will continue to look at it and come to the Board with information as we have it. I would suggest that if folks have ideas put it in writing, we have gotten a lot of interesting comments in writing and have looked at every single one of them. That is a much more constructive way to engage. We are not going to answer questions back and forth from the podium.

Harrison resident Jill Valenti said she has been in touch with Rye Brook and they have their first draft of gun shop legislation and that is being proposed December 13th. It is difficult as a citizen to look at a neighboring town that has moved so fast on something.

Village Attorney Kraut said I learned over time that just because someone proposes a law or adopts a law doesn't make it constitutional. We are aware of this and we are watching it and we are going to continue to watch it.

Harrison resident Mary Toulouse asked what is the status of security and safety for our children and community members? Is there a plan in place?

Village Attorney Kraut said we have an extraordinarily active police department; we have full time assigned community police officers assigned to the downtown areas. I have a high degree of confidence that our police department will be vigilantly watching any new store. Other then the Chief making a comment that we are aware of, certainly we would not discuss publically any plans that we have that are specific to safety for obvious

Harrison resident Maggie Winter asked the Board that if we have questions about this man and whether he was operating a legal gun store out of his home; are you telling me you are not going to answer that?

Village Attorney Kraut replied, that is right.

Harrison resident Maggie Winter asked the Board why if the citizens that have elected you are not allowed to have answers about the way things work in the town? How can I get answers to these questions? We want to know these answers so we can feel more comfortable with the processes that go on in the town.

Village Attorney Kraut replied he was not saying you can't get an answer to your question; rather he was saying it is not done at a town board meeting. We can have a discussion about this information but we are not going to do it at this meeting.

Supervisor Belmont replied that his office is opened every day and he calls everyone back; it is a walk-in environment. Come and see us anytime.

Councilwoman Amelio explained that our e-mails are on the Town website. You are free to call us. We are all assessable to you.

Harrison resident Rachel Estroff addressed the Board. She appreciated that the Board has been so accessible and appreciated that the Board has been so responsive. She said it's our role as advocates, citizens and residents to continue to press forward. I hope you see it as a partnership where we engage in our role and you have to do your due diligence.

Harrison resident Matt Benson addressed the Board. He wanted to make a suggestion. When citizen's write with reasonable notes on this issue I suggest that members of the council respond to them; I have yet to get a response.

Councilman Malfitano said he wanted to respond. We have all received your emails. Anything that has come that is questions, case law and suggestions have all immediately been referred to the law department for their review and comment.

Harrison resident Matt Benson said another suggestion is that the Town Board and the Law Department look at the permitted table of uses and existing ordinances, which prohibit, in the central business district, a newspaper establishment. The last time I looked the notion of Freedom of the Press and Freedom of Speech is well protected under the Constitution. There is an existing ordinance today that says the Building Department, if it is a newspaper establishment, can say it is not a permitted use. I would like you to look at that and adopt that into your thinking about what and what can't be done.

Supervisor Belmont exclaimed he was glad everyone was here and wanted them to know that we have been in contact with neighboring communities and they have yet to contact us back. I find it difficult to believe that Rye Brook is ready to pass a law, I have been in contact with the Mayor and the Village Manager. I have been in contact with the Federal Government, ATF and the Center for Gun Vigilance. I have reached out to the Board of Education and they reached out to me; I said we would love their help and I'm still waiting to hear back. We are not giving up and please realize that.

Harrison resident Jerry Dominus said if he wanted to open a porn shop in Harrison would that be permitted? It is protected speech but are there ways to manage where such speech gets articulated?

Village Attorney Kraut said the short answer is that is one of the places that is being looked at as a reference point for separation and distance restrictions.
