I would like to take a moment of silence for the murder of George Floyd.

I am committed to educating myself and the town board on how to be an advocate for those affected by intolerance and racism.

I want to thank councilwoman Leader for putting together a meeting with some members of our Town that she and I had yesterday with the Police Chief to discuss their concerns. It was a productive meeting and carried forth a bi-partisan effort that I fully support.

As most of you know, we have one of the safest communities in the country and that is a reflection of the hard work and dedication of our fine men and women of our police department. Our police dept first received accreditation from the NYS Criminal Justice Services in 2009 – an accomplishment only a fraction of departments achieved that applied for it. HPD has further renewed its accreditation each year since 2009 to the present.

Accreditation is a thorough and independent review of the entire operation of our police department by NYS. It runs the entire gamut from training to operations to administration of the department which includes a review of our policies and procedures.

Each year and for the last 11 years the police department has to satisfy 132 NYS standards established by NYS Criminal Justice Services and they have done so.

Our police department is one of the finest in the county and because of that we have enjoyed numerous recognitions by national publications that we have one of the safest towns in the nation.

Many residents have reached out to my office with questions and concerns that they have for and about our police dept. over the last few days. We will strive to answer as many questions that our residents have in a transparent way. I have asked our IT dept to set up a specific email address for those questions or concerns that residents have about our police dept. It will be hpdquestions@harrison-ny.gov.

While I think we have an excellent dept., every organization can find room for improvement. Towards that end, I fully support the use of body cams for our police department and the use of them by all members of our uniformed divisions that interact

with the public. I will ask the board for a resolution to fully fund the purchase of the necessary body cams that are needed and to use our surplus if needed.

I look forward to having a continuing dialogue with our residents and our police dept. over these important issues that we are now facing

I would like to make the motion to purchase all body cams that are needed for the police department and to have this purchase expedited. May I have a second.






