**C. PUBLIC HEARING**

**1. CONTINUE TO THE MAY 21<sup>ST</sup>, 2020 MEETING**

Continuation of Public Hearing regarding Proposed Local Law regarding Amending Chapter 5 entitled "Ethics, Code of" by repealing and replacing Section 5-4 entitled "Representation of private interests" of the Village Code of the Village of Harrison.

**E. ACTIONS AND RESOLUTION**

1. Request by Purchasing Department to issue Purchase Order numbers 400880 and 400881 to Vance Country Ford in the amount of \$44,037.13 each for Ford F250 pick-up trucks with plows. The total expenditure equals \$ 88,074.26. Items will be purchased through Dutchess County Contract DCP 94-18 and Westchester County Contract WC-20058. Funds are available within the capital fund.
2. Request by Purchasing Department to issue Purchase Order numbers 400882 and 400883 to Genessee Valley Ford in the amount of \$35,253.00 each for Ford Explorers SUV. Total expenditure equals \$ 70,506.00. Items will be purchased through the Town

of Greece Contract – 2020 Sedans and SUVs. Funds are available within the capital fund.

3. Request by Chief of Police, John Vasta, for approval to turn Barnes Lane between Purchase Street and Lake Street and the entire length of Avondale Road between Calvert Street and West Street into a “Parking prohibited at all times” highway. Both roadways are narrow with double yellow lines where parking is currently allowed. When cars are parked, approaching traffic is forced over the double yellow line into the opposite lane.
4. Request by Commissioner of Public Works, Anthony Robinson, for approval of \$2,000,000 for the 2020 Town Wide Pavement Preservation Program proposed in the DPW 2020 Capital Budget. Further request for the Purchasing Department to issue a Purchase Order to Indus, Inc. in the amount of \$260,000 to begin work on the 2020 Town Wide Pavement Preservation Program. Funding for the \$260,000 is available in Capital Accounts 18HW05 and 19HW05.
