Local Law No. 1 of 2022

Amending Chapter 35, entitled "Taxation" by repealing and replacing portions of Section 35-10(B)(6), of the Village Code of the Village of Harrison.

On motion of Trustee Evangelista, seconded by Trustee Brown,

RESOLVED, to amend Chapter 35, entitled "Taxation" by repealing and replacing portions of Section 35-10(B)(6), of the Village Code of the Village of Harrison, regarding the maximum real property tax exemption for Cold War veterans as follows:

Section 35-10(B):

6. "Qualified residential real property" means property owned by a qualified owner which is used exclusively for residential purposes; provided, however, that in the event that any portion of such property is not used exclusively for residential purposes, but is used for other purposes, such portion shall be subject to full taxation and only the remaining portion used exclusively for residential purposes shall be subject to exemption provided by this section. Such property shall be the primary residence of the Cold War veteran, or of the unremarried surviving spouse of a Cold War veteran; unless the Cold War veteran or unremarried surviving spouse is absent from the property due to medical reasons or institutionalized subject to such time limitations, if any, as are set forth in Section 458-b(1)(f) of the New York State Real Property Tax Law. Qualified residential real property shall include any real property or co-op ownership held for the benefit of a veteran, whether held in trust or otherwise.

When enacted, the attached Local Law would, with certain exceptions, provide such qualified owners with an exemption to the extent of fifteen percent (15%) of the assessed value of their residential real property; provided, however, that such exemption will not exceed seventy-five thousand dollars (\$75,000) or the product of seventy-five thousand dollars (\$75,000) multiplied by the latest state equalization rate of the assessing unit, or, in the case of a special assessing unit, the latest class ratio, whichever is less. The basic Cold War veteran exemption is in the highest amount authorized by Section 458-b of the Real Property Tax Law.

This Law shall take effect immediately upon filing with the Secretary of the State of New York.


