Dear Mr. Amodeo

Sealed bids for the Town-Wide Sanitary Sewer Rehabilitation Project Contract No. 2 – Trenchless Repairs were opened on April 19, 2023 at 1:00 p.m.

The lowest total base bid price received was from National Water Main Cleaning Company (NWMCC) in the amount of \$1,862,233.55. Prices for bid alternates were also received but due to budget constraints these alternates will not be awarded. We have tabulated all bid proposals received and no mathematical errors were found. We reviewed NWMCC's bid proposal package and found it to be complete as required. The Town has worked with NWMCC before and they deemed NWMCC's work satisfactory, thus, NWMCC's references were not contacted.

Therefore, based upon our review of each bid proposal, and with concurrence from the Town Board, we find no cause or reason why the Town of Harrison should not award the project to NWMCC in the amount of their total bid price of \$1,862,233.55.
