As requested, we respectfully submit the following proposal for work associated with the following scope of work, at the above referenced project.

#### Nelson Ave Concrete Curb Scope:

- Code 753
- Mobilization
- Saw cut existing pavement
- Excavation for curb installation, inclusive of offsite disposal. Our proposal is based on 900 LF
- Furnish and install 4" of item-4 subbase material under proposed concrete curb
- Furnish labor, material, and equipment to install concrete curbs. Our proposal is based on 900 LF
- Furnish and install 4" of topsoil, seed, mulch behind curb
- Furnish and install K-Crete backfill and 6" of asphalt binder at front of curb road patch
- Furnish and install one handicap ramp with ADA tile
- Demobilization

Our lump sum proposal for the above referenced work is: Seventy-Six Thousand Five Hundred Dollars and No Cents (\$76,500.00). Sales tax is not included and will be added unless a tax-exempt certificate is provided.
