

Re: 2014 REVISED Proposed DPW Capital Budget

Dear Mayor Belmont and Members of the Village Board:

Attached please find for your review the 2014 Proposed Revised DPW Capital Budget. At the request of the Board, significant cuts to the original proposed budget were made in consideration of both the current economic conditions and the needs of the department necessary to maintain services and infrastructure.

Purchases for vehicles and equipment were either eliminated or reduced. The automated sanitation program will move forward with the purchase of one new vehicle instead of 2 as requested in the original proposal and the unit cost has been reduced by \$60,000 by selection of a straight frame unit in lieu of a drop frame. The sewer jet request remains, as this is used for emergency sewer calls and is a critical piece of equipment.

All items contained in the original proposed budget for building/facility improvements have been eliminated with the exception of our general building improvement request. The Gleason Garage Generator Project has been eliminated resulting in the loss of a \$50,000 grant from FEMA. In the event of an emergency, we would use the portable 100kw generator as a temporary power source for the garage.

Also eliminated was the funding for Mintzer Center design and construction. This will necessitate regularly scheduled inspections to insure building safety. The scaffolding erected shall remain in place indefinitely and may need to be expanded pending further inspections. A final determination on the viability of this building must still be made so that the need for future requests can be considered or eliminated.


Funding requests for infrastructure were eliminated or reduced. Requests for tree removal, sidewalks and fencing/parking lots were all eliminated. Funding for the reconstruction of Barnes Lane has been eliminated and will be reconsidered in next year's budget proposal. The funding request for resurfacing of Town roads has been eliminated with the understanding that it is the intent of the Board to make \$750,000.00 available from the Highway Contingency Fund for this purpose. These funds shall be supplemented by approximately \$300,000.00 remaining in the

2013 DPW Capital Budget approval for resurfacing. This will insure that sufficient funding is available for much needed road repairs.

Lastly, funding requests remain intact to address necessary compliance issues, sewer repairs and pump station improvements design.

Your consideration and support of the Department's requests are much appreciated.
