Dear Mr. Amodeo:

We appreciate this opportunity to continue to support the Town and provide the Town with a proposed scope of work for pre-bid assistance, construction administration and monitoring services for the Pilgrim Road Drainage Improvements project. The following is a summary for our proposed scope of work and engineering budget estimate.

SCOPE OF WORK

Task 1 - Pre-Bid Assistance

Woodard & Curran will assist the Town during the pre-bid stage of the project by completing the following services:

- 1. Attend and lead the pre-bid meeting
- 2. Record and issue the pre-bid meeting minutes
- 3. Coordinate with the Town for issuance of pre-bid meeting minutes in the form of an addendum to the contract.

The pre-bid meeting is an opportunity for all prospective bidders to become familiar with the site, and for the Town and Engineer to discuss key construction items for consideration in the bid. All questions and clarifications discussed during the pre-bid meeting will be addressed in the minutes, which will be issued as an addendum for incorporation into the contract.

Task 1 - Estimated Schedule: Within one week from pre-bid meeting day.

Task 1 - Woodard & Curran Labor and Expenses: \$4,500.

Task 1 - Budget: \$4,500 lump sum.



Task 2 - Construction Administration

Woodard & Curran will provide the following professional engineering services during construction:

- Perform a review of all material, equipment and shop drawing submittals.
 Correspondence with the Contractor and return of submittal reviews.
- Attend and assist progress meetings to review progress and discuss necessary coordination between the Contractor, Town, and residents.
- Coordinate Contractor RFIs, as well as potential unforeseen site conditions resulting in design changes and conflicts as they pertain to approved plans, specifications, and bid form.
- 4. Assist with the review and approval of Contractor payment requisitions.

Task 2 - Estimated Schedule: To be determined; from start to end of construction.

Task 2 - Woodard & Curran Labor and Expenses: \$12,000 assumes an estimated construction period of 9 weeks at 6-7 hours per week of engineering support (average fee of \$260 per day).

Task 2 - Budget: \$12,000 lump sum.

Note: Final fees will be based on actual construction period at the average fee per day.

Task 3 - Construction Monitoring

Woodard & Curran will provide the following services as part of this task:

- 1. Perform full-time on-site construction monitoring for the duration of construction.
- 2. Complete field reports documenting work completed each day.
- Monitor the installation of the proposed drainage pipes, utility crossings, earthwork, paving activities and other work specified for this project.

Task 3 -Estimated Schedule: To be determined; from start to end of construction.

<u>Task 3 - Woodard & Curran Labor and Expenses</u>: \$45,000 assumes an estimated construction period of 9 weeks at 40 hours per week (average fee of \$1,000 per day).

Task 3 - Budget: \$45,000 lump sum.

Note: Final fees will be based on actual construction period at the average fee per day.
