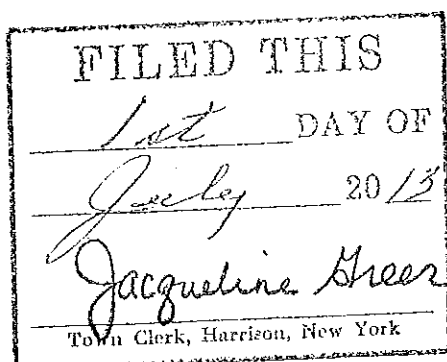

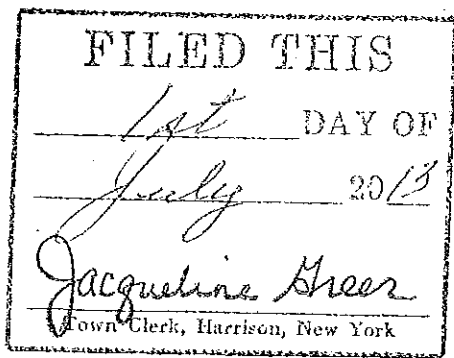
PRESENTATION BY COUNTY LEGISLATOR

Harrison resident Lucille Held said she wanted to know the \$1,800 that the policeman is going to get for the dog; is it in addition to the regular salary.

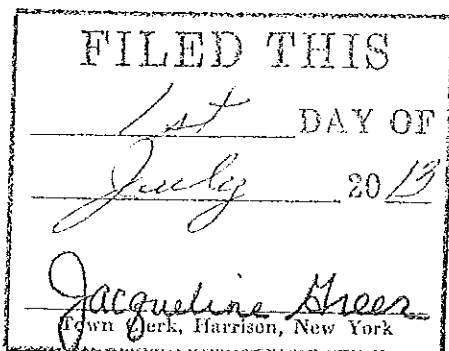

"UNIFORM NOTICE OF CLAIM ACT"

Village Attorney Jonathan Kraut said that he had one item that was time sensitive. Our State Legislators have passed a law that will be effective June 15, 2013 giving municipalities until July 15th, which will change the service method of Notice of Claims. A Notice of Claim is required to be served on municipal corporations as a condition proceeding to law suits. In the past, the Notice was to be served directly to the Town. What has been changed is the Secretary of State is going to be designated statewide to accept on behalf of municipal corporations. What the town has to do now is designate an official within the town who will be the designated person to receive a mailing from the Secretary of State indicating that a Notice of Claim has been filed. He recommended that we designate the Town Clerk as the person who will receive that mailing as there is already a process in place in the Clerk's office.
