PRESENTATION AND ACCEPTANCE OF THE 2014 TENTATIVE BUDGET FOR THE TOWN OF HARRISON BY TOWN CLERK JACKIE GREER

Town Clerk Jackie Greer presented the 2014 Tentative Budget to the Town/Village Board. This budget was submitted to the Town Clerk's Office on October 30, 2013.

Supervisor Belmont said that there were extra copies if anyone wanted one. It will also be available on the town's website in the morning. Supervisor Belmont said he wanted to briefly go over a few things that are in the budget at the November 20th meeting; Comptroller Maureen MacKenzie would do a power point presentation. He explained to the Board that for 2014 the budget is under the 1.6% cap mandated by the State of New York. The Tentative tax rate increase is approximately 3.8%. On a \$500,000 home that would equate to approximately \$100 in additional taxes.

Comptroller Maureen MacKenzie said she would do a presentation at the next meeting. The Tentative Budget did come in under the cap even though you will see a rate of 3.854%. That rate doesn't really relate to the levy that the Governor talks about when he discusses the 1.66% cap. That is based upon the dollar levy. This means we can really go up 1.66% of the levy. There are also other exclusions that come into play. We have a carry over from last year because we came in under the cap so they give us the opportunity to use that in this year's budget. We also have a growth calculation that is in here; because the Town increased our assessment roll we are also allowed to add more money to the levy.

Supervisor Belmont said that he wanted to report that last week Moody's Investors Services gave us an uptick in our bond rating. We went from a AAA 3 to AAA 2. Moody's talks about our strengths and strong wealth levels.

Councilman Malfitano said he wanted to add to Mr. Belmont's comments so our residents could get a clearer perspective of what the new rating means. He had yet to check the statistics but speculated that the Town of Harrison, having been upgraded by Moody's Investors Services, probably represents less then a handful of credits that received an upgraded rating in New York State. This is significant in an economic environment across the land where it is much more frequent that municipal entities are facing downgrades not upgrades. He concluded by saying he thought that the new rating is a tremendous accomplishment and it makes strong statement about the financial health and the management that this Board has provided under the Supervisor's leadership.
