

Mayor Belmont said it is similar to the water. We have our sanitation department pick up commercial properties for which they are charged a fee by the Department of Public Works. If they do not pay their sanitation bills within the allotted time, it goes on their tax bills.

Trustee Cannella said the reason for this is it becomes a lien so it improves the town's ability to collect it.




