- 1. Public Hearing: Attorney Frank McCullough, partner in the law firm of McCullough, Goldberger & Staudt, on behalf of his client, Life Time Fitness, for a Special Exception Use Permit, to demolish the soon-to-be vacant Gannett building at One Gannett Drive, and to construct a new facility of approximately 209,000 square feet on the approximately 22.4 acre property.
- 2. Public Hearing: Request by Frank McCullough, partner in the firm of McCullough, Goldberger & Staudt, LLP to consider an application by JSL, LLC (Acqua Tots Westchester Swim School) for a Special Exception Use Permit in the SB-O Zoning District pursuant to Sections 235-14 and 235-16 of the Zoning Ordinance of the Town of Harrison which allows a secretarial, business, trade or similar school in the SB-O Zoning District They are proposing to construct a new building on the property which would

house the Aqua Tots Westchester Swim School, on the property known and designated as Block 622 and Lot 9 on the Tax Assessment Map of the Town of Harrison.

The affected area is Oakland Avenue and Grant Avenue. The Public Notice Proposed Local Law _____ of 2011. Amending Chapter 235 entitled "Zoning" Section 235-4 and Section 235, Attachment 3 entitled "Business Districts Table of Use Regulations" and amend the Zoning Map of the Town of Harrison to rezone certain parcels.
