- Dead animals will be considered non-emergency animals. Any dead animals(s) will be picked up between the hours of 8:00 a.m. and 4:00 p.m. **Monday - Saturday. Animals reported on Sundays or Holidays will be picked up the next day and disposed of properly.**
- Ace will require a police officer to be on the scene of all emergency (sick, rabid) animals until a trapper arrives to remove it to avoid a liability to the Town of Harrison. **If no officer is present and or the animal is not at the scene, the Town will be charged flat fee of \$185.00.**
- **Under no circumstances should Town employees advise or assist in removing animals from private property on to Town property.**
- For the sum of \$9,975.00 (nine thousand nine hundred and seventy-five dollars) per year (November 1, 2012 - October 31, 2013, November 1, 2013 - October 31, 2014).
