

#### 2014 - - 384 OLD BUSINESS

Harrison resident Jimmi Pritchard spoke about her concerns with the renovation of Riis Park. A contract has been awarded to Vernon Hills for improvements totaling \$119,385. Most of it is for new fence work and the grounds. It includes \$10,000 for a new flagpole when the other bidders listed \$5,000 to \$7,000 for the work. Ms. Pritchard was concerned that the fence had points on the top and was concerned they could be a potential danger. She suggested that what were really needed are sidewalks and a new gazebo. She went on to say that in one document the plan refers to concrete paving but there isn't any cost listed for it. Who will do that work and what will it cost? She was concerned that if bids are going to go out for that, when will it be done? What have we budgeted for the total costs of improvements for that park? We only have \$400,000 in that recreation fund and we've already spent over a quarter of it. Are we thinking we can get the rest of this done from the recreation fund?

Supervisor Belmont answered no. As I've said at the last few meetings we are doing some improvements that are really necessary. It will address the eyesore of the current fence and will remove the trip hazards in the park. We are spending 25% of what is in the Recreation Fund to get these things done. We are looking for donations for a new gazebo if anyone is interested in donating. Bids have gone out and construction is due to start right after It's Great to Live in Harrison Day to run simultaneously with the construction of the library.
