



#### V - - 2014 - - 189 OLD BUSINESS

Harrison resident Rob Porto said he wanted to comment on a few things. I think it is a disgrace that you are asking people for donations for a new gazebo when you are buying all this new equipment. It is my understanding that you have more equipment then you have men. When the people of Harrison want to get something nice like a new gazebo of \$30,000 you ask for donations. Why don't you spend some money on the people of Harrison?

Commissioner of Public Works Anthony Robinson responded to Mr. Porto by clarifying that the trucks that we are replacing are vehicles that are twelve years old or older. They are rusted out and are going out to auction for parts. The new trucks are a necessity. We do have men to operate them.

Harrison resident Frank Mucci said he had two complaints tonight. I have been talking to the Chief about putting up a "No Left Turn" out of the Dunkin Donuts parking lot. When are we going to do something about it? My other issue is I burn the ceremonial flags for the Veterans of Foreign Wars (VFW). I want to have this on Saturday morning, October 11<sup>th</sup> at 11:00 AM this year. I have over three barrels to burn this year. To date I have burned about 35 barrels of flags. These are flags that are torn and ripped apart and people just don't know what to do with them. The Federal Government says you have to burn the flags so I started burning the flags roughly three years ago.

Mayor Belmont said that is the Police Department open house and the fire trucks will be up at the police station at that time. How about this be done late afternoon at 2:00 PM. The open house at the Police Department is from 10:00 AM to 2:00 PM. Maybe we can coordinate this for Veteran's Day. I'm here for you and we will come up with a time and date.

Chief of Police Anthony Marraccini said he just wanted to give you a little background. I've known Mr. Mucci for about 35 years when I became a Junior Volunteer Fireman and he was the Chief at the time. It is engrained in me anything he tells me to do I have to listen to him. We evaluated this "No Left Hand Turn" sign a number of years ago and we did receive a number of complaints about it and that's why it was taken down. I'm happy to re-evaluate it for Mr. Mucci and see if it does improve traffic conditions. Without question I can take care of that. If it is warranted I will approach the Board on it and see if it could be put back up. The Chief thanked the Board for their support and their positive attitude.
