

AUTHORIZATION TO ENACT A FOUR (4) HOUR PARKING LIMIT ON ELLSWORTH AVENUE, WEBSTER AVENUE, NELSON AVENUE, AND BROWN PLACE

Mayor Belmont said he would like to talk about parking on Ellsworth and Nelson Avenue. I would like to get four hour parking on these streets.

Trustee Malfitano asked the Chief if he had recommendations on this.

Police Chief Marraccini said it is a constant struggle for us with these commuters and these residents being so close. We do expand the hourly limits when we get complaints. As we expand it the commuters still move further out. I know we have problems on Ellsworth, Nelson, Webster Avenues and Brown Place.

Mayor Belmont said he would like to have four hour parking restrictions on Ellsworth, Webster, Nelson Avenues and Brown Place.

Village Attorney Kraut asked if we are doing portions of these roadways or the roadways in their entirety. I would like to hear the Chief's recommendation to the Board. There may be some logic in doing the whole street particularly if you wind up going forward with the district so you don't have people jumping over the district line where there are no restriction.

Police Chief Marraccini recommended the entire portion of Ellsworth, Webster, Nelson and Brown Place have the four hour limitation between 8:00 AM and 6:00 PM, Monday through Friday, except holidays.

On motion of Trustee Cannella, seconded by Trustee Malfitano,

RESOLVED to authorize four (4) hour parking limits from 8:00 AM to 6:00 PM, Monday through Friday except holidays on both sides of the entire streets:

Ellsworth Avenue Webster Avenue Nelson Avenue Brown Place
