Trustee Malfitano said since we had so many emails and calls sent to all of us about these roads, maybe the Commissioner of Public Works could comment on the timing of this and where the focus is going to be first?

Commissioner of Public Works Robinson replied by explaining that as everyone knows these roads are in severe disrepair. Based on the pavement management study that the Board approved, these roads have been identified as roads that have a base failure. That requires much more work to repair and replace and in essence it requires a number of investigative type tasks in order to know what the sub grade materials consist of and what is the best way to remedy the situation. They will take core samples and do test pits on these roads. These samples will enable them to come up with a design mix. We are using existing funding now that we had from last year's budget that was approved. We want to perform the analysis and the design right away. According to the recent schedule that we got we could have the design drawing by the end of May and that would mean construction by August. Given the time frame of completion we could be done by the end of October.

Trustee Malfitano said this is specifically for these roadways, West Street, Underhill and Barnes Lane and we are looking at a time frame of completion in October?

Commissioner of Public Works Robinson replied yes, at a minimum. This is going to address the design portion of those three roadways however; we only have funding for construction for West Street and Underhill.

On motion of Trustee Cannella, seconded by Trustee Amelio,

RESOLVED to authorize a professional services contract with VHB for work associated with the development of construction and bid documents for the roadway rehabilitation of West Street and Underhill Avenue and pavement design of Barnes Lane at an amount not to exceed \$58,600.00.
