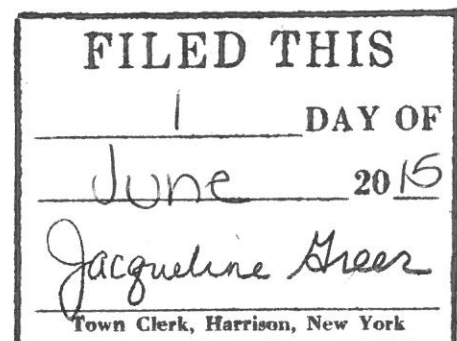

- Dawson Court and Forest Lake Drive

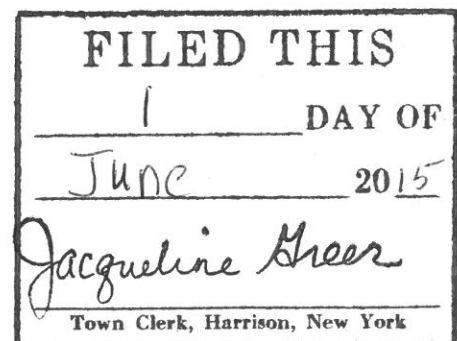

AUTHORIZATION TO MODIFY THE NO PARKING RESTRICTIONS OF FOREST
LAKE DRIVE AND DAWSON COURT AND SECTION 38-52 OF THE V.T.O.

Police Chief Marraccini addressed the Board concerning the parking restrictions on Dawson Court. We had a number of issues with residents there. Anytime a resident has a guest or during holidays, pretty much on a daily occurrence, people are parking on one side of Dawson Court. We spoke to a few residents to get a feel as to what side they prefer the parking to be on. I think the consensus was as people drive up Forest Lake they would rather have the parking in front of their house so people don't have to turn around.

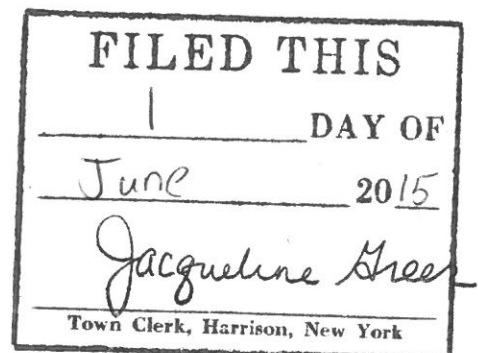
