PUBLIC HEARING – Proposed Local Law of 2011 amending Chapter 155 entitled "Garbage, Rubbish and Refuse."

D. PERSONNEL:

1. Notification by Commissioner of Public Works Anthony Robinson that approval was given at the April 7, 2011 Board meeting to hire two part time Sanitation employees effective May 16, 2011.
