# V - - 2011 - - 063 <u>TABLED: AMEND ARTICLE 41, SECTION 1662-C OF</u> <u>THE NEW YORK STATE VEHICLE AND TRAFFIC LAW</u> RE: RESIDENTIAL PARKING PERMITS IN WEST HARRISON

Mayor Joan Walsh asked Anthony Marraccini, Chief of Police to explain his request to amend Article 41, Section 1662-c of the New York State Vehicle and Traffic Law, authorizing residential parking permits in West Harrison.

Chief Marraccini explained that in West Harrison there are parking restrictions during day time hours that are a burden on the residents. The parking restrictions are meant for the area around Preston School, where teachers and staff park on residential streets for extended periods of time. Residential parking permits in these areas would help the residents to leave their cars in front of their homes.

Mayor Walsh questioned if those residents would be required to get a permit?

Chief Marraccini responded that the residents would need a permit to park on the street during these restricted hours in order to prevent them from being ticketed.

Trustee Vetere asked: will there be a fee for the permit.

The Chief answered it's up to the Board.

Mr. Vetere stated that there should be a fee if they're coming from out of town.

The Chief replied further explained that the proposed residential parking permits would be beneficial to the residents of West Harrison particularly the homeowners in and around Pearl St, Main St, and the Boulevard. These streets have seen an influx of non-resident parking leaving no spaces available for local residents. This permit will allow the residents not only the ability to park during restricted hours but also allow them overnight parking.

Mayor Walsh questioned how many permits each resident would be issued.

Chief Marraccini responded by stating each resident who wishes to obtain a parking permit must be able to provide proof of residency. He concluded by stating that he strongly believes creating these proposed permits would improve the quality of life issues in and around the troubled areas of town.

Trustee Sciliano thanked Chief Marraccini for bringing this proposal to the Board. As a member of the West Harrison Neighborhood Association, Mr. Sciliano stated these proposed permits have been needed for quite a while especially for the area of Main Street where residents of White Plains park their cars on the West Harrison side of the street and leave their cars there overnight.

Village Attorney Robert Paladino explained that in 1998 the Town Board requested the State Legislature to pass enabling legislation that would allow the town to create a residential parking permit system in a specified area of downtown Harrison. The enabling legislation was very specific in allowing the town to have such a parking regulation. The Town Board at the time did not agree with a particular wording of the legislation and therefore did not enact such parking previsions in the downtown area. Mr. Paladino further explained that if the Board wishes to enact a residential parking regulation in West Harrison, they would need to once again request the State Legislature to pass similar enabling legislation as they did previously in 1998.

A conversation began concerning the requirements the state legislature would have for such proposed regulations. Such provisions had included that 20% of all spaces within the permit area be available for non-residents. Another provision which was discussed focused on the state legislature's requirements regarding commercial vehicle parking in the permit area. Mr. Paladino explained that the town does not need the State Legislature to act on any regulations for town owned parking lots. The town would only require enabling legislation from the legislature regarding parking regulations on public streets. Chief Marraccini explained that parking in the downtown area is burdened by commuter parking while West Harrison is burdened by non residents parking. He further requested that legislation of the downtown area be modified and that legislation for parking in West Harrison be requested.

Trustee Cannella stated that as we do not know what provisions the state legislature would require and asked that the matter be tabled so that the Attorneys could research the matter.

#### V - - 2011 - - 065 DISCUSSION RE: PARKING IN THE PARK AVENUE, PURDY STREET LOT

Village Attorney Robert Paladino stated that there have been many complaints about overnight parking in the Park Avenue, Purdy Street lot. Various options have been discussed, one being a permit system for businesses located in the area, being able to purchase up to a certain number of permits that would allow them to park their commercial vehicles in that lot overnight, from 5pm to 8am. In 1982 the Town Board established in that lot authorized parking designations that permits could be sold to local businesses at the rate of a residential commuter parking rate. In this instance it would be \$600 per year, allowing commercial business to purchase overnight parking permits but those vehicles would have to be removed from the lot by 8am.

Trustee Amelio asked about week-end parking.

After a lengthy discussion it was agreed that Mr. Paladino and Chief Marraccini would meet and return to the July 7<sup>th</sup> Board Meeting with recommendations.

Sam Fanelli suggested that on Harrison Blvd. in West Harrison parking should be eliminated from 8pm to morning.

Chief Marraccini stated that resident permit parking would resolve a lot of the non resident parking issues.

Mayor Walsh stated that the Board would try to have this done within two weeks.

Chief Marraccini believes that it would take more time than two weeks because of the amount of work that needs to be done by the Law Department to draft this legislation.

Attorney Paladino asked if the board wants to ask the state legislature for enabling legislation.

Trustee Cannella responded he wanted to see the current limitations that might come from the legislature.

Trustee Amelio asked if they are also talking about residential cars that are parking in municipal lots when talking about commercial vehicles.

Chief Marraccini replied that possibly there should be permit overnight parking for our Municipal lots. That would be enacted after the restaurants close.
